Global Small and Mid-Cap Fund ("GSMF" or "the Fund") provides investors with a portfolio strategy that invests in global small and mid-cap shares across multiple countries and industry sectors.

The Fund is an actively managed multi-manager portfolio with the Underlying Investment Manager(s) investing predominantly in global small and mid-cap shares whose investment strategies emphasize performance above the benchmark while aiming to control risk.

The Fund aims to provide investors with a total investment return (after fees) that outperforms the benchmark over periods of seven years or longer.

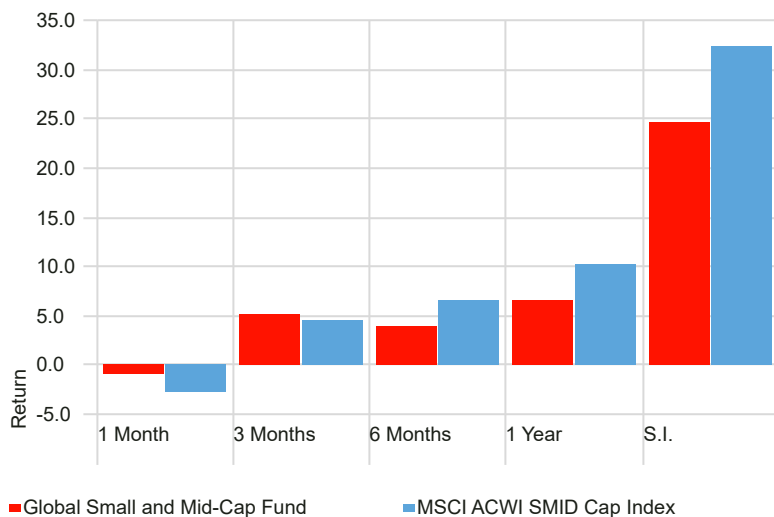

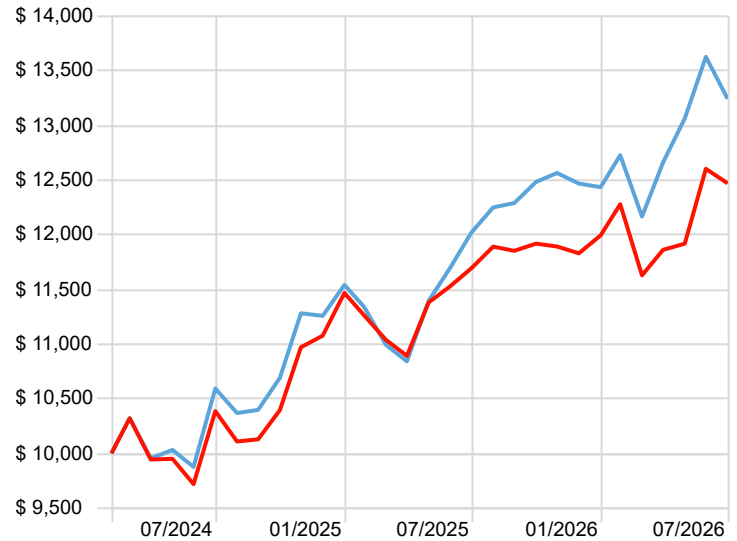

Investment Growth of \$10,000 Since Inception

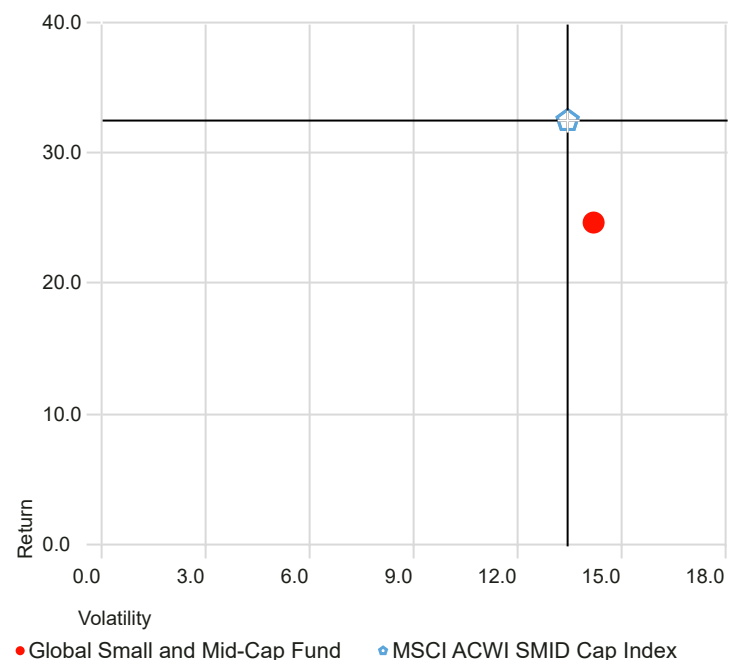
